Consequently the same cut-off date i.e. Wednesday, 21<sup>st</sup> September 2016 would record entitlement of the shareholders, who do not cast their vote electronically, to cast their vote at the 16<sup>th</sup> AGM on Wednesday, 28 September, 2016.
  - ii) The remote e-voting period commences on Sunday, September 25, 2016 (10.00 AM IST) and ends on Tuesday, September 27, 2016 (5:00 P.M. IST). During this period, Members of the Company, holding shares either in physical form or in dematerialized form, as on the cut-off date of Wednesday, 21<sup>st</sup> September, 2016 may cast their votes electronically. The remote e-voting module shall be disabled for voting thereafter. Once the vote on a resolution(s) is cast by the Member, the Member shall not be allowed to change it subsequently or cast the vote again.
